





- Call to order at 6:09 p.m.
- A Quorum was not reached. All votes were taken and passed after a phone vote was taken from Rion Myers to complete the Quorum.
- Meeting minutes from the November 2011 meeting were reviewed and approved.
- November 2011 Treasure's Report was reviewed and accepted subject to Finance Committee review.
- New Business New Members; 2 Student, 1 Associate, 3 Affiliate, 9 Professional were approved along with Jack McFadden from our own chapter receiving a Life Membership.

**President's Report** – President Pickenpaugh stated that various executive officers will each go to a different surrounding state conference to represent our organization.


Finally, Ryan Meyers was selected as the "Member of the Year" and will be so recognized and the Annual Conference.

# **Random Lines**

You know that I like history, especially Ohio history. One of the greatest internal improvements ever made in the State of Ohio was the Ohio Canal System during the first half of the 19<sup>th</sup> Century. This opened the state to the East Coast and to the products from that area. It also opened the East Coast markets to Ohio agriculture and manufactured goods. How did this come about? I thought you would never ask.

The canal building years extending from 1825 until 1848 were significant in Ohio history because of the canals' profound effect on the state's economic development prior to the Civil War They brought Ohio from an economically isolated, almost wilderness, state to a populous, wealthy and powerful one. The canals opened the heartland of Ohio to the Eastern seaboard cities and the rest of the world, but it did not come easily.

The importance of interior transportation routes was discussed in the mid and late 18<sup>th</sup> century by the likes of George Washington and later by Thomas Jefferson and by Ohio's Thomas Worthington. There were suggestions made that a canal be built between Lake Erie and the Ohio River to facilitate transportation between the Mississippi River and the St. Lawrence River, thereby connecting New Orleans and the Atlantic Ocean and opening the markets of the "wilderness" states. There was great deal of opposition in Congress to expending federal funds for internal improvements. The log jam was finally broken when Congress funded the initial construction of the National Road, the first Federal improvement project. (More about that in future articles.)

In 1818, the population along the Lake Erie shore traded with Canada and the Atlantic coast by way of the Great Lakes and the St. Lawrence River. The population in Southern Ohio traded with New Orleans using the Ohio and Mississippi Rivers. The center of the state had only roads that were little more than trails though the woods. Something had to change. In 1822, the General Assembly, over sectional opposition, passed the canal act authorizing the employment of an engineer to survey a route for the canal and prepare cost estimates and also established a seven member Canal Commission.

Charles Geddes, former Erie Canal engineer and Commissioner Alfred Kelley (from Cleveland) surveyed several possible routes for the canals. The Canal Commission decided that the route between Cleveland and Portsmouth was the most feasible. In order to gain Southwestern Ohio support, a second

canal between Cincinnati and Dayton was also chosen with a promise of a future canal reaching to Toledo.

The bill authorizing the construction was passed in February, 1825. Although this was a State project, the work was done by private contractors bidding for each section as a single contract. The early wage for a laborer was 30 cents per

day, sunrise to sunset, plus board and lodging. Many experienced workers came to Ohio after the construction of the Erie Canal in New York. On July 25, 1825, construction commenced. On July 4, 1827, the first boat, "State of Ohio" traveled from Portage Summit to Cleveland. The banks of the canal were lined with jubilant citizens, bands and salutes.

Construction was often delayed by bad weather, a shortage of engineers and surveying equipment and illness among the workers. Malaria, cholera and smallpox took a toll and the death rate was high. Somehow, the canals were completed and opened full length for transportation of people, farm goods and manufactured items. The State of Ohio, as a whole, prospered but the days of the canal were already numbered. The railroads, starting in about 1850, began to supplant the canal by being able to work 12 months a year, operate day or night and travel much faster. The canals stayed around until the major flooding of 1913. The legislature, having grown tired to throwing money at a dying transportation system, cut off funding. The canal era in Ohio had ended.

During its run, the canals brought the State of Ohio out of the wilderness and into modern America. It carried Ohio goods to the outside world and brought the world to Ohio. During its working life, it spawned many towns and cities along its route, grew businesses and fostered immigration into Ohio. Although it became a drain on the state budget, it more than paid for itself by helping Ohio grow.

Today, the canals in various parts of the state are experiencing a rebirth as parks, hiking and biking trails and history centers. After 185 years, the canals still carry a romantic image of a bygone age and are still an asset to the State of Ohio.


