

Paul presented a video covering the performance of a lane closure that had aspects applying to surveying in a work area that would require this. The publication "Guidelines for Traffic Control in Work Zones" as distributed by the Ohio Department of Transportation was also reviewed. Members looking to obtain a copy of this should go to www.dot.state.oh.us/traffic. A nominal fee will be charged.

During the question and answer period, discussion was directed at occupying an intersection for a brief time without doing a lane closure. Mr. Ciupa suggested reviewing the option of using your survey vehicle for additional protection if feasible, in addition to safety cones and signage.



Chapter Delegates Report Meeting Friday, October 13, 2006

- 4.2 The 2007 State Budget was submitted and will be voted on at the November 10th meeting for approval.
- 5.3 It appears that the law will move forward to remove the prohibition of the use of electronic seals. The State has noted that 65 other states allow the use of electronic seals. The County Engineers Association of Ohio and ODOT support the removal of the prohibition. It is unclear at this time if the use of encryption software will be required when using an electronic seal.
- 6.2 ODOT is revising the Right-of-Way manual and will likely provide a R/W plan title sheet that will allow multiple surveyors to sign for different portions of the plan. For example in a situation where ODOT may provide the centerline alignment for the project and another surveyor/consultant performs the r/w surveys or topography both would sign for their particular contributions to the development of the plans.

- 6.3 The State Board is still looking for examples of violations by title companies issuing title insurance without requiring a mortgage location survey. Anyone with knowledge and evidence of this practice should contact the State Board.
- 7.13 The PLSO State office would like to know if Chapters have funds and specifications for scholarships as the Scholarship Committee is reviewing and revising the standards and guidelines for scholarships.
- 7.15 A motion was passed to approve the revisions to the PLSO State Constitution and bylaws. The Constitution will be sent to all members for a vote of approval.
- 7.3 The NSPS Board of Governors withdrew it's support of the NAFTA Bill to allow surveyors from Mexico and Canada to practice in the U.S. However, it was determined later that the issue is more complicated and agreed to continue to review the bill in order to not allow another agency the opportunity to approve it. Also, NSPS is attempting to have a bill passed by Congress legislating National Surveyor's week (for 2007 March 18-24). In the past it has always been presented to the President to sign a proclaimation each year. By having the legislation passed this will eliminate the need to do this each year. Currently, the "bill" is in the House of Representatives for a vote. Surveyors are encouraged to write their representative. You can find information about how to contact your representation thorough the ACSM website www.acsm.net.








Lets take it up one more notch. The aforementioned game plan gets the newsletter available online. Copying restrictions and costs have kept the newsletter black and white. An electronic copy allows the pictures and advertisements to be in color and

greatly reduces our costs. This will open up other options for the newsletter budget. Suggestions have been made such as sending copies to engineering and building departments and mayor's offices throughout our Chapter boundaries.

The easiest way to get to this electronic copy is to save the document file to a PDF file. A PDF file reduces the size from over 110 Mb to around 2 Mb. A dialup internet connection downloads that size file in about fifteen minutes. About one minute if you have a broadband connection. Send me an email hoy7419@cs.com requesting a copy and you'll be on the distribution list. If I already have your email address, you've had the newsletter for a few days. All you need to open, view and at your option print the file is Adobe Acrobat Reader which is a free program downloaded at www.adobe.com. Requesting the electronic copy will remove you from the mailing list and put you on the email list.

In the next few months we'll find even easier ways to download the file.
