



#### Editor's Message, Final

Eight years ago I took over as editor of the Cleveland Surveying News. Many great things have happened within PLSO and the Cleveland Chapter over those years. This newsletter has gone through a few subtle design changes to get to this current standard that fits my vision for a professional and standardized presentation. All 8 years of CSNs are on our website, along with some prior newsletters before that from issues that we had and scanned. I reviewed Cuyahoga County's and all adjoining county GISs, with input from each GIS director, which helped make GIS professionals aware of land surveying and PLSO. You get out of PLSO only what effort you put in.

Time hasn't been nice to our chapter with member participation and membership, for other professional organizations too. The Great Recession drained about 40 members from the Cleveland Chapter, and those members haven't come back. Sadly it seems we've had as many members pass away as have joined our chapter over the past couple of years. Eight years ago we regularly had 8 to 10 members attending our executive committee meetings. We revised our controlling documents (constitution and by-laws found: <u>http://cleveland.plso.com/contact.html</u>) allowing for six officers down from ten to address the trends at the time of difficulty finding members to run for election to make participation less of a commitment. However, the trend has continued with our lack of new members joining the chapter. 2011 was the last year we had all three "presidential" offices filled. One year we were able to fill only 3 of the 6 officer positions which means all three of us had to show up at the executive committee meeting for have the quorum requirement met. The past two years we've had 4 of 6 officer positions filled with 2016 looking to be the same. Louise Veverka has stepped up to be President-Elect again as the first chapter member to start the Presidential path more than once. Looking at our chapter roster, it is filled with past presidents and many *senior* surveyors.

I want to thank those that have contributed to this newsletter over the years, writers, photo takers, and advertisers. We have members still willing to write for the CSN and happy advertisers wanting to continue their partnership with us, yet at this time this newsletter does not have an Editor for the next issue. I didn't know newsletter editing when I took over the CSN just as you aren't experienced at every sort of survey you accept to perform. It's about serving your profession and society. You get out when you put in as I and Mr. Dailey have often reminded you.

#### Surveyor of the Year - Steven J. Metcalf, PS

Steve Metcalf got his first taste of surveying at the Cleveland Metroparks with Nate Orchard as an extra set of hands in the wood of the park system. His time spent with Nate, allowed Steve to see another profession he didn't know existed. After his time working in the public sector, with Park system and the City of Akron water department, he found his way to Neff & Associates.

At Neff & Associates, Steve worked under (3) professional surveyors, Tom Neff Jr., Frank Tilisky, Marty O'Conner, and a great crew chief John Denega, Jr. In the 90's with the housing & construction boom, Steve obtained

lots of field survey time with the opportunity to work "sun up to sun down" and Saturdays till the work was done. "I had to learn quickly to keep pace, listen to the tips & tricks, and understand the surveying vernacular, because we had lots of work to do."

Inter professional Affairs: Melinda reported that PLSO had a booth at the OTEC conference.

Education: Melinda reported that a survey program at Columbus State may be approved shortly. This will be a 2+2 program in conjunction with Franklin University. The program will be ABET reviewed (but not accredited)

Representative Louis Blessing III was nominated for the 2015 PLSO Legislator of the Year Award. Motion passed Representative Blessing was instrumental in supporting the Statue of Limitations for Ohio land Surveyor in 2014 and supported the legislation to waive liability for surveyors, engineers, architects and contractors when they volunteer their expertise at the request of local communities at times of declared emergencies due to natural disasters. He is currently sponsoring the proposed legislation that will require ethics as a component of the COD requirements

#### Surveyor Spotlight - Elton K. Cooper, PS

#### by Steven Metcalf, PS

#### What year did you become a surveyor?

Univ. of Akron Grad., Licensed OH Prof. Surveyor January 2015, but I have been in the surveying profession since August 2003.

#### What company do you work for, how long?

I presently work for The Riverstone Company located in Cleveland, Ohio. We currently staff nine office employees & two survey crews with robotic total stations, one of which I Crew Chief.

#### What lead you into the surveying profession? Why?

At 27 years of age I was still looking for my career path. I completed vocational training in computer aided drafting (CAD) in June of 2003. I was trained in

architectural & some small mechanical drafting, but I didn't have any success finding work. After three months of looking, a counselor at a job placement program ran by the City of Cleveland pointed me in the direction of Bemba K. Jones, a professional surveyor. I knew nothing of surveying profession, but Mr. Jones gave me an opportunity when no one else would give me a chance. After a few months of learning about the profession, I was hooked. I knew there was nothing else I would rather do.

#### Where you ever an intern or where did you start?

I was never an intern. By the time I started at The University of Akron, I had so much work experience I was allowed to bypass the intern requirement. Also, when I was nearing graduation the economy went south so there weren't many internships opportunities available.

#### Who were your mentors?

I can't really say I had a mentor. I have worked for a number of firms and I learned a lot along my journey, but no one has took me under their wing. I've worked for some good firms with excellent surveyors and some horrible firms as well. Each experience has made me a better surveyor. I am thankful to have worked for my present employer, Ed Dudley of The Riverstone Company. Mr. Dudley is an old school surveyor and I learned a lot during my time in the office working alongside Mr. Dudley and his staff. I am also thankful for my time spent working for Michael Benza & Associates. I gained very valuable field experience working under the supervision of Adam Treat & Dragomir Elez, the crew chief. #### Surveyor of the Past - William (Will) J. Dempsey 1929-2012

At the 2016 PLSO Annual Conference next month in Dayton, chapter member and past president Will Dempsey will be recognized as a Surveyor of the Past. Here is more about Mr. Dempsey.

William J. (Will) Dempsey P.S., passion for surveying began while serving with the United States Army Corps of Engineers in 1949. He received his education at John Carroll University, Fenn College, Case Western Reserve University and the U.S. Army Engineer Center at Fort Belvoir, Virginia. He started his own business Dempsey & Associates, Inc. in 1964 and was the owner/manager until he retired in 1994.

Before founding his own firm in 1964, Will was employed by the Land Title Guarantee & Trust Company and George M. Garrett & Associates with responsibilities ranging from field party chief to executive managerial duties. In the early years of PLSO Dempsey served four years as regional vice chairman for Cuyahoga, Lorain, Geauga, Lake and Trumbull Counties. He was elected the Ohio Delegate to the American Congress on Surveying and Mapping in 1986 through 1989 where he represented Ohio surveyors on the Board of Governors of the National Society of Professional Surveyors and on the Great Lakes Regional Council.

He is a charter member of the Professional Land Surveyors of Ohio (PLSO), a past president and trustee of the Cleveland Chapter. His memberships included The Ohio Society of Professional Engineers, Knights of Columbus, Kiwanis, The Cleveland Engineering Society, The National Society of Professional Surveyors, Board of Governors, and was elected a Fellow of the American Congress on Surveying and Mapping (A.C.S.M.). He has served four years on a national committee of A.C.S.M. conducting a study of mortgage loan surveys. Will also served two years on the committee to write the standards for mortgage loan surveys in Ohio. He was named the PLSO, Cleveland Chapter's Surveyor of the Year in 1980. Will initiated the successful lawsuit against Chicago Title Insurance Company for the illegal practice of surveying resulting in publication of case law in Ohio.

Will and his wife, Rosemary raised ten daughters and three sons, which over time grew to include 29 grandchildren and seven great grandchildren; His hobbies included aerial photography, computers and snorkeling. He was a pilot who loved to photograph job sites from above in his Cessna 182 and provide pictures to his clients. His most cherished memories, however, is the time spent with the family over the years, especially at the family farm in Medina, Ohio.

Whereas, Will loved to read. He also engaged in activities in the religious realm and taught Confraternity of Christian Doctrine classes to high school seniors at St. Mark's Parish in Cleveland where he was also a lay minister. Will was an instrument rated commercial pilot. After retiring to Florida in 1994 Dempsey served five years as a board member of the Church Without Walls and tutored inmates at the Marion Juvenile Correctional Facility in Lowell, Florida.

Will's business is still in operation, now run by his son Christopher, also an Ohio licensed surveyor. William passed on August 28, 2012 at the age of 82

#### **OUPS Fee Information**

## Registration

What is the purpose of the new damage prevention registration fee?

In order to pay the costs of enforcing the new damage prevention laws, users of the One-Call (Call Before You Dig) system must register with the PUCO and pay an annual registration fee of not more than \$50. Failure to register may result in a fine of up to \$2,500.

#### Who must register?

Any commercial excavator, developer, designer, or utility operator conducting business in Ohio who participates in (or is required to participate in) the One-Call system must register and pay the registration fee. Individuals who use the One-Call system to perform excavation work on their own private property and do not do excavation work commercially are *not* required to pay the registration fee.

#### How do I register?

The PUCO will work with the Ohio Utilities Protection Service and the Oil and Gas Producers Utilities Protection Service to obtain a list of registrants. The PUCO will then issue invoices to those companies and individuals with instructions that include the amount to pay and where to send the payment. In other words, all you have to do is wait until the PUCO sends you an invoice.

#### When will I receive an invoice?

Enforcement will begin Jan. 1, 2016. Invoices should be expected sometime in May or June of 2016 and March or April in subsequent years. Because the registration fee will be based on cost, the amount could vary each year but will not exceed \$50.

## **Enforcement process**

#### How do I submit a complaint?

A complaint (request for inquiry) can be filed here. To do so, you must be an aggrieved party as defined by the law. In other words, you must be a person with duties and obligations under damage prevention law and directly involved with or impacted by the alleged compliance failure.

#### What happens after a complaint is submitted?

The PUCO will notify the complainant (person who submitted the complaint) that the case has been assigned and is under investigation. The PUCO will notify the respondent (person who committed the alleged compliance failure) within 10 business days and will provide the details of the complaint.

#### What will an investigation consist of?

The PUCO investigation will center on getting statements from both the complainant and the respondent regarding the alleged compliance failure. Both parties will also have an opportunity to provide supporting documentation such as pictures, locate tickets and other relevant material.

#### Who decides the case?

Cases are reviewed by the UTC, a committee of industry representatives. Once the UTC has made a decision, both parties will be notified by the PUCO of the outcome. If you are interested in attending a UTC meeting, upcoming meeting schedules and agendas will be posted below.


#### How can I appeal a decision?

Either party may file a request for reconsideration. Written applications must be filed within 30 days and must state the grounds for reconsideration. Information about filing documents with the PUCO can be found on our **docketing page**.

#### NSPS Business Meeting

#### October 8th & 9th, 2015 - Sandusky Ohio

Here than are a list of initiatives and observations from our fall meetings:

- The ALTA/NSPS Standards have been approved by both organizations and we will have new standards that take effect on February 23, 2016.
- NSPS will prepare a position statement on U.A.S. (unmanned aircraft systems) regulations and operations. We've also signed on with other mapping organizations in crafting a letter to urge the F.A.A. to codify the government's regulations for operating this technology in a more urgent manner.
- The young surveyors group had a productive meeting and started to think about bylaws, sub committees and addressing tasks that many have offered up for them to consider. Approximately 11 of them attended the Board of Directors meeting on Friday.
- We intend to broaden the awareness of the Young Surveyors and our National Society at educational institutions across the country by inviting a student to attend our meetings as our guest and write a short review that will be shared with all surveying programs. The program will be administered by the Young Surveyors and funded through NSPS Board of Director donations. We intend to have a student in attendance at the 2017 spring meeting.
- Our President Jon Warren & President-Elect Tony Cavell have each made a significant effort to re-align our committees and offer specific charges for these committees to work on. PLEASE consider having your constituents sign on to the email distribution lists for a committee by contacting the chair of that committee. It's a great way to be involved without the commitment of attending our meetings.
- The Director from Alaska requested support regarding the setting of monuments by the BLM when creating Townships that would be further subdivided and sold by the State of Alaska. As you might have guessed, the number of monuments being set has been drastically reduced. Our Government Affairs Committee will review and comment on the matter
- Certified Survey Technicians (CSTs) at all levels and existing membership can now have their annual certification fee waived by maintaining a membership in NSPS.
- The NSPS Joint Government Affairs Committee shoulders a great deal of responsibility in representing surveyors across the nation on Capitol Hill. Please review their report for the many tasks and/or accomplishments they have had over the last 6 months. Mr. Pat Smith, Chair of the Committee, requested direction from the BoD on the following matters:
  - NSPS will provide a position statement on the PHMSA (Pipeline Hazardous Materials Safety Agency) Proposed Rule which contains a number of references to surveying and mapping – and provide a standardized position to our state affiliates
  - NSPS will provide a position statement to the House Financial Services Committee which is considering modifications to the National Flood Insurance Program (NFIP), either to implement an improved working process or privatize the effort
  - Support the addition of the Small Business Administration (SBA) to Federal Acquisition Regulation (FAR) Council – given that many small businesses are effected by FAR regulations.
- The NSPS 100% Membership Program has been very successful. We currently have 47 states participating, just under 17,000 members, and continue to offer our help to those still considering the program.
- We continue to collaborate with NGS and participate in quarterly meetings on various initiatives

- We are recognized by ABET as the professional organization for evaluating 31 Surveying Programs across the country.
- Our CST program that has been a monumental success and run by several individuals for many years, and even decades. Their succession plans require them to look for individuals who are interested in serving on the CST Board and upholding the fine standard which has been set. Please consider this opportunity and contact President Warren if you are interested in this appointment.
- The NSPS Foundation Concluded their Cruise Raffle The winner is Randall Myers of West Virginia. He is Past President of both the West Virginia and Pennsylvania Surveying Societies. Congratulations Mr. Myers.
- We had previously decided that an At-Large Director(s) would represent those NSPS members who did not belong to a 100% Membership state. Given that we are now down to three states who do not belong, we passed a motion whereby the Past-President will provide representation to those individuals, albeit in a more cost effective manner.
