





Surveyor Spotlight - Ryan Snezek - PS

What year did you become a surveyor?

Univ. of Akron Grad., Licensed OH Prof. Surveyor 2010

What company do you work for, how long?

Stephen Hovancsek & Assoc. for 7 1/2 years and have recently become partner. We are 10 employees, 1 full time survey crew, & are looking to hire a swing player or a Co-op for office/ field use with a busy year projected ahead of us. We are City Engineers for multiple cities within the area & development in Northeast Ohio has kept us really busy.



What lead you into the surveying profession? Why?

My Father Tom Snezek, P.S. brought me into the profession at an early age. Myself, Sean my brother, and my sister Britney all helped Dad with his field work. We were cheap labor, but really this survey work kept us all fed and paid for our Catholic Education. It taught us the strong Snezek work ethic, which is ..Why sit on the couch & loaf, I could work, earn, and save for the needs and fun later.

Where you ever an intern or where did you start?

My list is long and all brought me great experience: I started very young with my Dad, later I worked for L.V. surveying - Louise Veverka, Reitz Engineering, McSteen & Assoc., K.S. & Associates after graduation and then the economic turndown happened. And finally I landed at Stephen Hovancsek.

Who were your mentors?

My Father Tom Snezek, Louise Veverka (L.V.), Mark Yeager (KS), Rick Castello, and unlicensed crew chief who taught me the world in the field, and definitely Bob Smoltz at Hovancsek.

Have you always surveyed in Ohio? Other states? Or Parts of Ohio?

Ohio only – but have everywhere north of Columbus, as far as Zanesville to Findlay & in between.

Do you prefer the field or the office better? Why?

When I was younger I loved the field work, the outdoors, & new territory. Now that I'm in my 30's, I enjoy the office portion, working with clients. I get to wear both White & Blue Collars.

What surveying instrument & vehicles do you use? Did you have a favorite over the years? We use the Focus 10 Robot and the Spectra Epics 35 GPS with a Silverado Pickup or Ford Ranger. My favorite instrument so far has been the Trimble S6 Robot because the Auto-lock feature is the best.

Is there a type of surveying you are interested in but you're not currently doing? Laser Scanning surveying would be interesting.

What item/ classes/ topic would you like added to the Annual PLSO conference classes?

I would like more information and the actual math breakdown examples behind the Ohio State Plane Grid to Ground conversions. Gary Schuller Cleveland PLSO seminar in October was a great overview, maybe he can be added for the next one with math examples. Civil 3D tips are also always helpful.

Do you have a good funny surveying war story?

I went to an automobile agency today for some service work. I was happily surprised at the quick, friendly and knowledgeable attention I received. The auto dealers learned some time ago that their service department was usually the main point of contact with prospective return customers. They have gone to great lengths to make the customer feel both appreciated and wanted. This feeling will carry over into the sales room.

We surveyors should follow the same path. The managers and the office staff work hard to make sure a client is well taken care of. Phone courtesy is a must. The client should be greeted warmly on the telephone and made to feel that their call is important. They should not be left on "hold" for too long. If the person they want to talk to is busy on another call, say so and give them the option of holding, getting a return call or calling back later.

The person that the client is contacting should be aware that, in the client's eye, their call is the most important. Respect the client enough to treat it that way. Give the client your undivided attention and then follow through on what you have promised them. How you, the manager handle the rest of the staff is completely up to you.

Your field crews are usually the only living being the client actually sees. What visual impression do they make? Is the vehicle neat and in good repair? Is it properly and obviously marked? Is your company name clearly visible? How does your crew look? Are they neat and presentable? Do they look like someone you would allow on your property or someone that would cause you to run and lock the door?

Technical and legal talent and ability is very important in our profession, but customer relations builds reputation and brings clients (and their acquaintances) back to your doorstep. Don't play it down, build it up.

Look, think and act the PROFESSIONAL.
