ORC 2305.09

<u>(E)</u> ...

An action for professional negligence against a registered surveyor shall be commenced within four years after the completion of the engagement on which the cause of action is based.

Surveyor Spotlight - Terry Worsech, PS

What year did you become a surveyor?

I received my Professional Surveyors license in 2001.

What company do you work for, how long?

I currently work for Neff & Associates for 7 months. I am responsible for Boundary Work and Set-up for Construction Staking in the office.

What lead you into the surveying profession? Why?

It began with my first real job with the City of North Olmsted in the Engineering Department.

Where you are you from originally?

I have lived in the Cleveland area all of my life and still reside in North Olmsted.

Where you ever an intern or where did you start?

No, I was never an intern, but as mentioned before, I started at the City of North Olmsted Engineering Department working on their field crew as a rod man. Later I became an instrument man, did various drafting work, Topo's, centerline surveys and sewer studies.

Who were your mentors?

At the City, I worked under Hugh Patton, then with Peter C. Zwick & Bill Wellcheck. Later then, I gained a lot of knowledge from working with Carl Craddock, J. Howard Flowers, Richard Allar, Richard Hantel and Dennis Seifert. All of these were a positive influence in my continuing as a surveyor.

Have you always surveyed in Ohio? Other states? Or Parts of Ohio?

Ohio only.

Do you prefer the field or the office better? Why?

I love the field, that is where I feel most challenged, and enjoy the freedom. But, the office is where I am at now. I do enjoy seeing all the work come to fruition, creating the map, and seeing the final product too.

What surveying instrument do you use? Did you have a favorite over the years?

I have used mainly Nikon total stations and Topcon robots.

Is there a type of surveying you are interested in but you're not currently doing?

Astronomical surveying

What item/ classes/ topic would you like added to the Annual PLSO conference classes?

Anything Jeff Lucas. I saw him at a prior conference and he is a good entertaining speaker.

Do you have a good funny surveying war story?

Doing some rough grade staking on a site in Brunswick Hills, the site was so muddy and wet that the guy I was staking with had to set one in the middle of what we thought to be a small puddle. Once he got into the small puddle, well, he was up to mid thigh quickly & had to be pulled out by a front end loader. He refused to do any staking in puddles after that.

What was the coldest/ hottest place or time your surveyed?

Back in 1978, we were doing a Railroad survey in Bedford Heights. The high temperature for the day was -10 and we were going through 3 feet of snow by the (Cont'd on Page 8)

Friday September 12, 2014 Call to Order 6:02 PM

-21 Officers and Delegates present, Quorum Established.

- Review and passage of July 2014 meeting minutes with minor changes.
- Treasurer's Report –Reviewed and accepted subject to the Finance Committee's review, as per the Charter guidelines.
- New Members New members list 2 Professional, 1 Affiliate, 1 Sustaining, 1 Retired and 2 Life membership applications were reviewed and motions passed to accept. Note that we welcome Benjamin Kearns, a new member to the Cleveland Chapter.
- Dean Ringle discussed potential road salt shortage projected for this winter.
- Discussed the upcoming GIS conference in Columbus for September 22-24.

Inter-Association Reports

- ODOT Jim Kenyon reported on the up-coming ACEC presentation on revamping ODOT contracts to be held on October 16th
- State Board of Registration Dean Ringle reported that at the National meeting in August discussion was held on the issue of modifying the Model Law by the year 2020 to increase the years of education needed to sit for state exams to five years or even requiring a Masters degree. The general opinion seems to be to leave it at a four year degree. Mr. Ringle has been appointed to a committee to analyze the evident "aging" of surveyors in Ohio as well as nationally. The committee will finalize a report next year. He asked for any thoughts and suggestions to help. Director Gilpin noted that Cincinnati State has added classes to work in conjunction with the University of Cincinnati to lead to Bachelors program.

- -P.A.C. fund balance = \$2,002.35. Personnel check donations are being accepted.
- -N.S.P.S. Governor Robert Akins reported: Still looking for an Ohio representative to log NGS monuments. NSPS has accepted our invitation to the Fall Conference in 2015 at Kalahari. 2015. He is still looking for comments on membership benefits ideas. Discussed the issue of Davis Bacon law applications of prevailing wages to licensed professional surveyors. He has been challenged by a Federal Government representative and asked the room for opinions or ideas.


